Questions for student (Lucélia de C. R. de Brito, Federal University of Piauí, Brazil)

- What motivated you to apply to the CLIFF-GRADS Initiative?
  - I highlight two points that motivated me to enroll in the program:
    - I- The great visibility that the participant in the beginning of a scientific career can achieve, mediated by the opportunities that the program offers.

II- And the opportunity to assimilate new knowledge in the area of mitigation of greenhouse gases in agriculture.

- What is the objective of your project under the CLIFF-GRADS Initiative? The project's objective is to measure N2O in organic grain production systems.
- What new knowledge/skills have you developed as a result of involvement in the initiative? Many skills/knowledge have been improved and / or initiated through CLIFF, such as: Methodology for collecting greenhouse gases;
  - Input Greenhouse gas samples into the gas analyzer (chromatograph)
  - Analysis of emission data with two, three and four collection points;
  - The use of Bootstraping methodology and exponential interpolation in the analysis and representation of N2O data;
  - Improvement of knowledge in the use of excel for the construction of charts and spreadsheets; planning and execution of a scientific experiment;
  - Manufacture of gas collecting chambers;
  - Scientific article writing;
  - Statistical analysis in experiment with subsubdivided portion.

Although I mentioned the intellectual gains linked to the professional field, I need to mention, even if only briefly, that there were many personal and cultural gains in participating in the program.

• What broader positive impacts have come about from being a CLIFF-GRADS student? It was positively impacting to know other realities and styles of work execution. This helped to expand and raise my professional references to a much higher level. Having the opportunity to work with a research team that CLIFF-GRADS has provided me with inspires and motivates me every time I feel discouraged. In a broader and more personal way, I can say that when you participate in a program the size of CLIFF-GRADS, the world view is transformed. For me there was a transformation in the way of seeing, feeling and feeling what is happening around me and in the world. I can say that I attribute to the program a greater development of a sense of global responsibility for the maintenance of Environmental quality on the planet. Thanks to the diffusion of experiences provided by CLIFF-GRADS, I have future plans for the development of strengthening actions aimed at the preservation of natural resources in the quilombola agricultural communities of my city.
